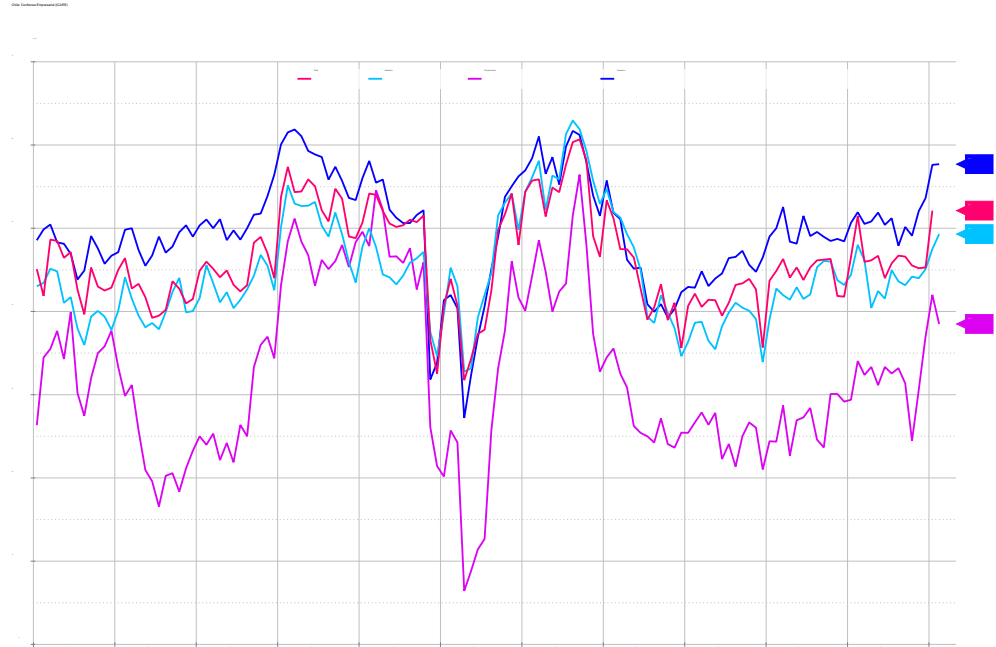
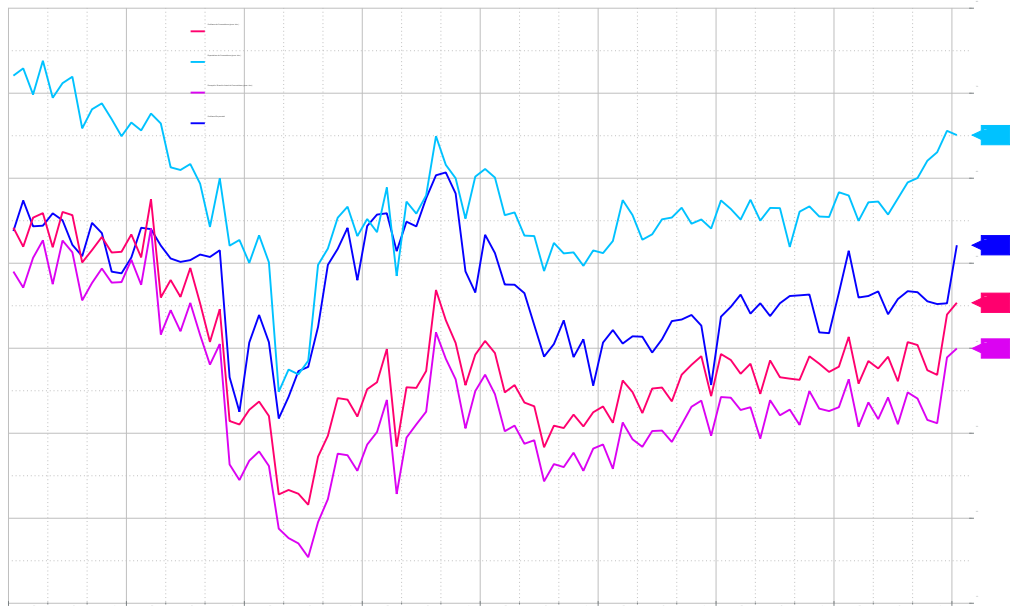
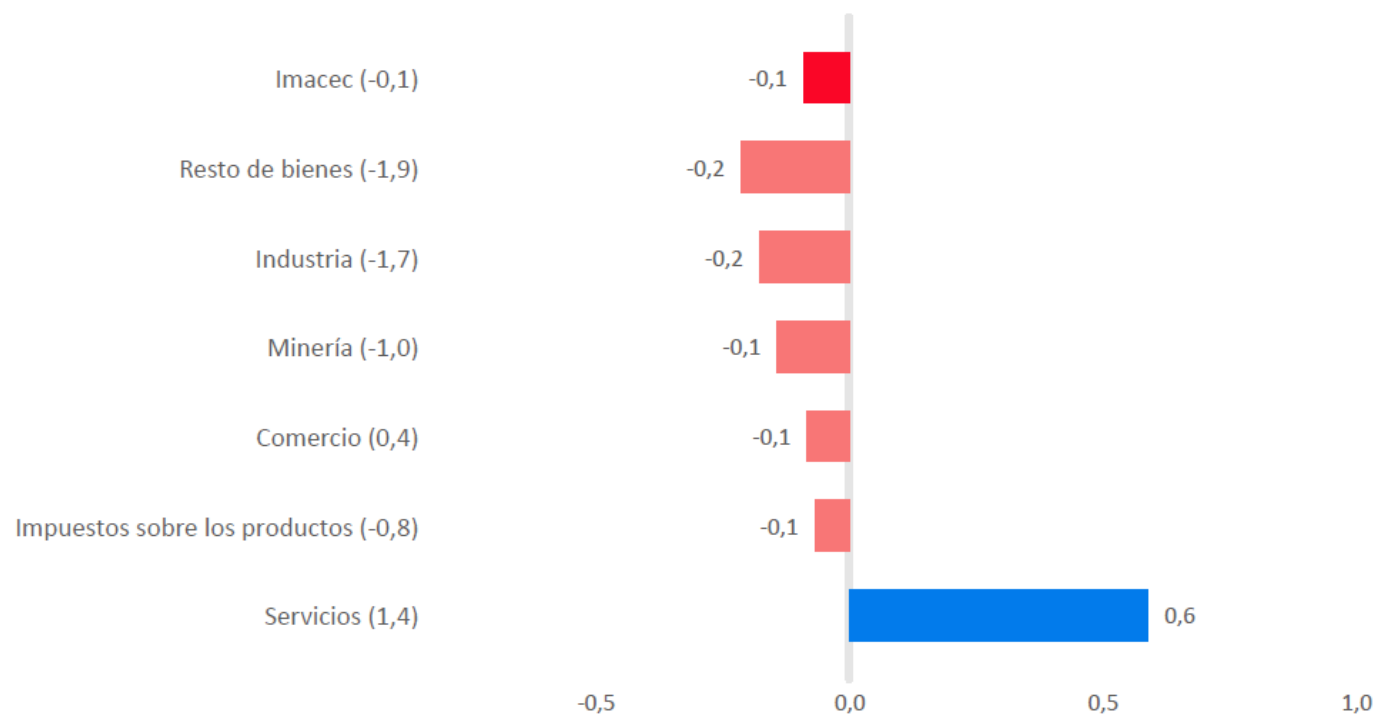
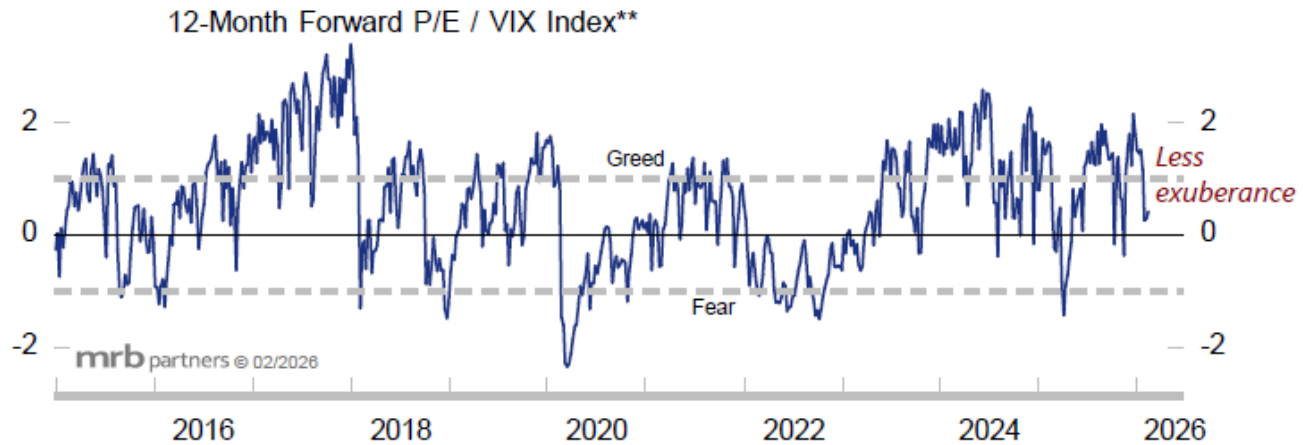


Gráfico 1: Contribución a la variación anual del Imacec
(tasas de variación y contribuciones porcentuales)



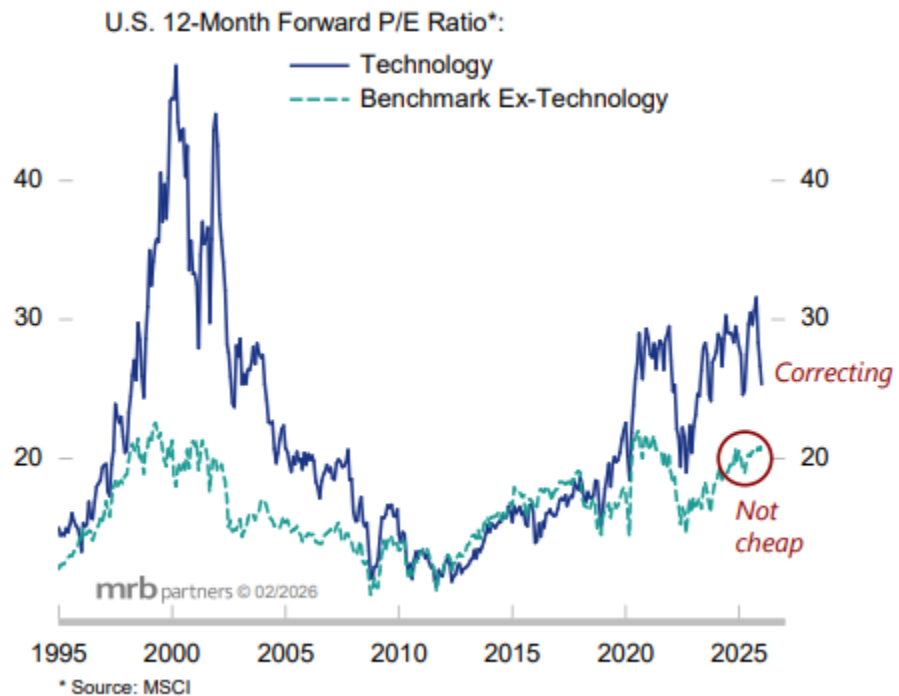
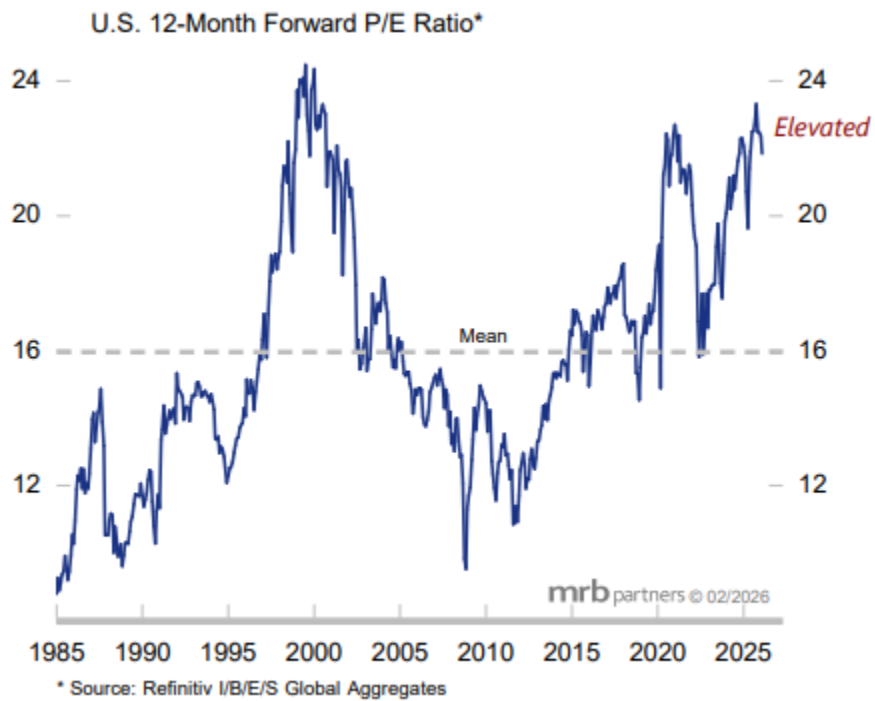

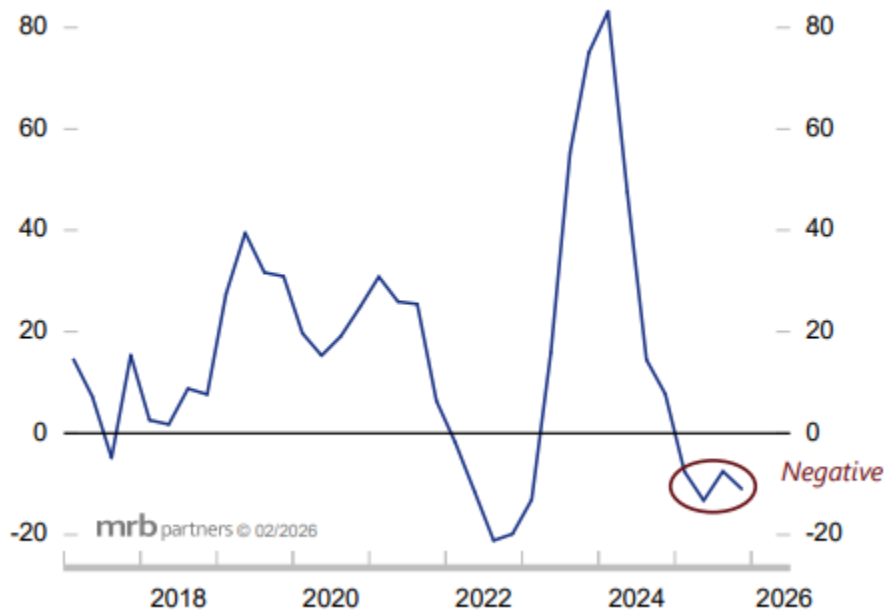

U.S.: Average Quarterly Capex-To-Revenues Of Hyperscalers* (%)

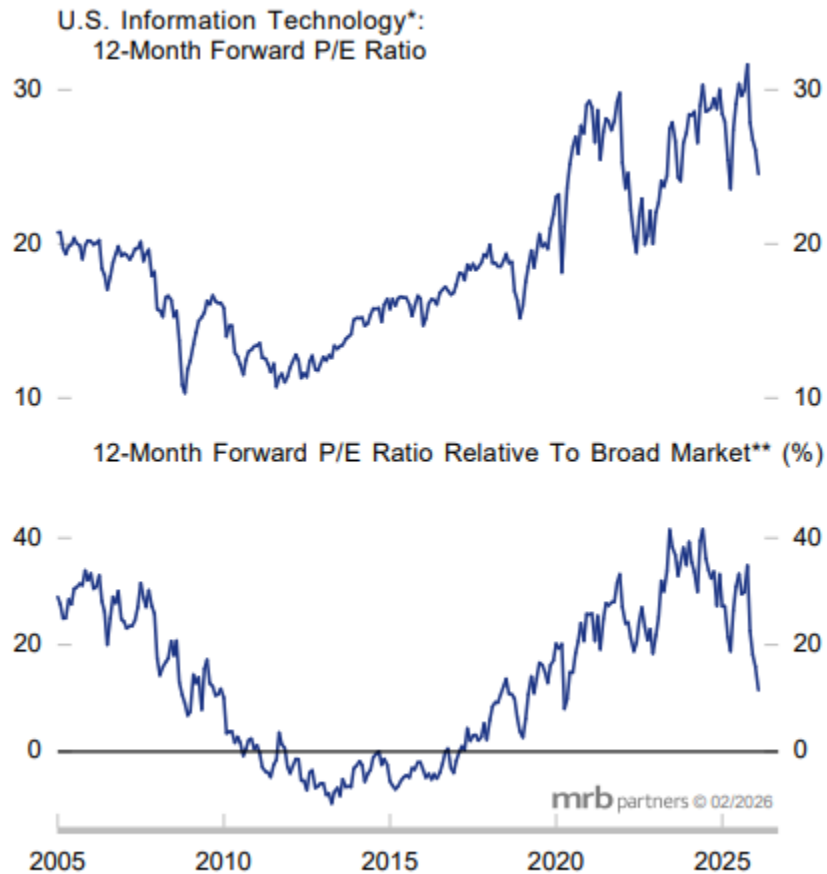

U.S.: Trailing 4-Quarter Free Cash Flow Growth Of Hyperscalers* (%YoY)

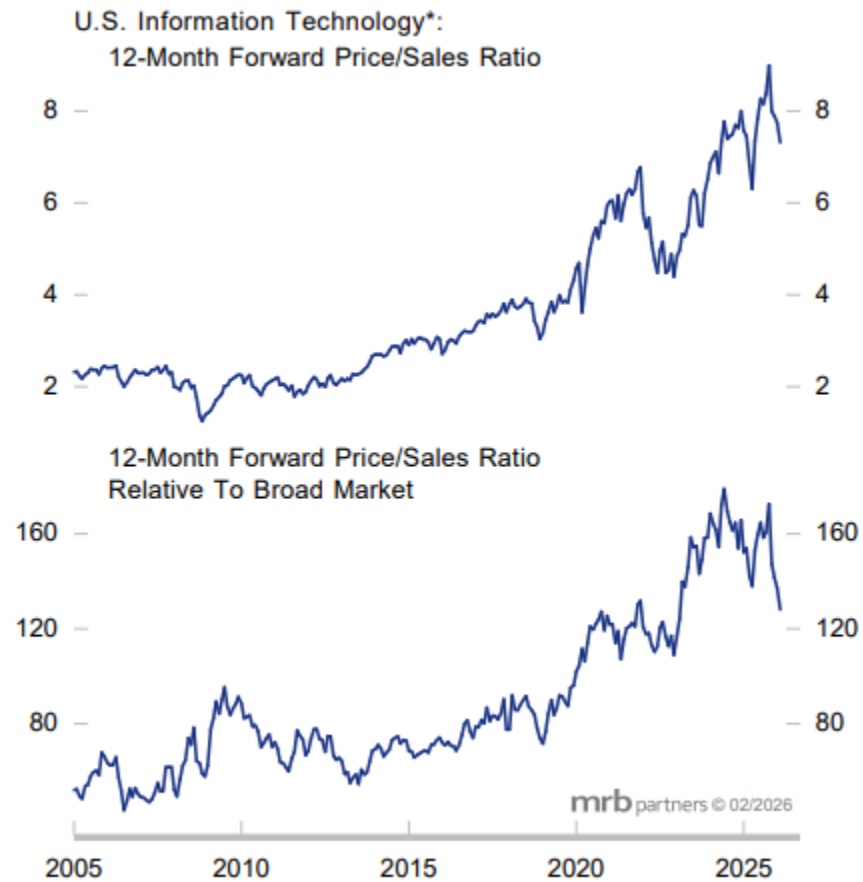

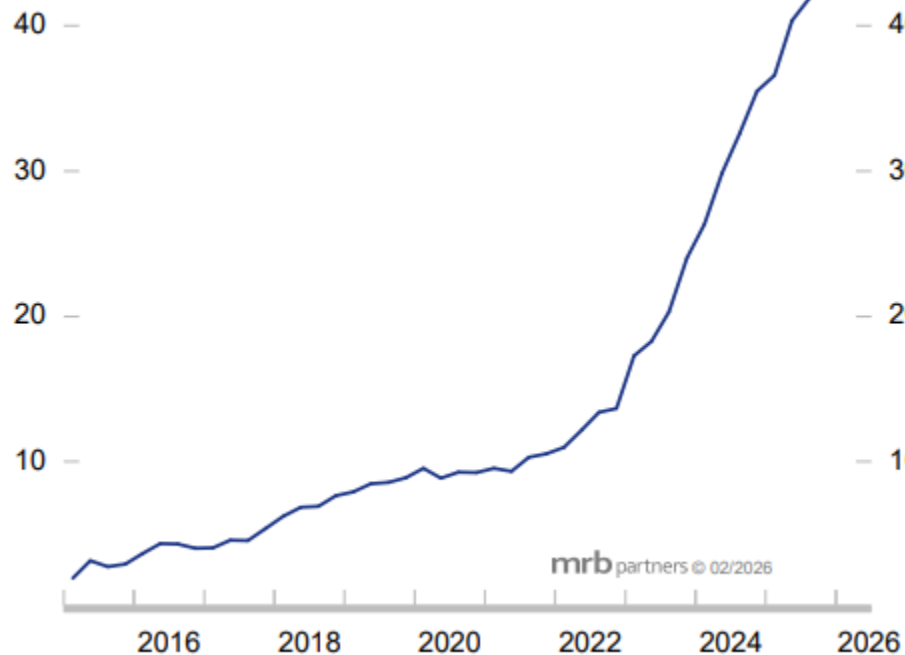

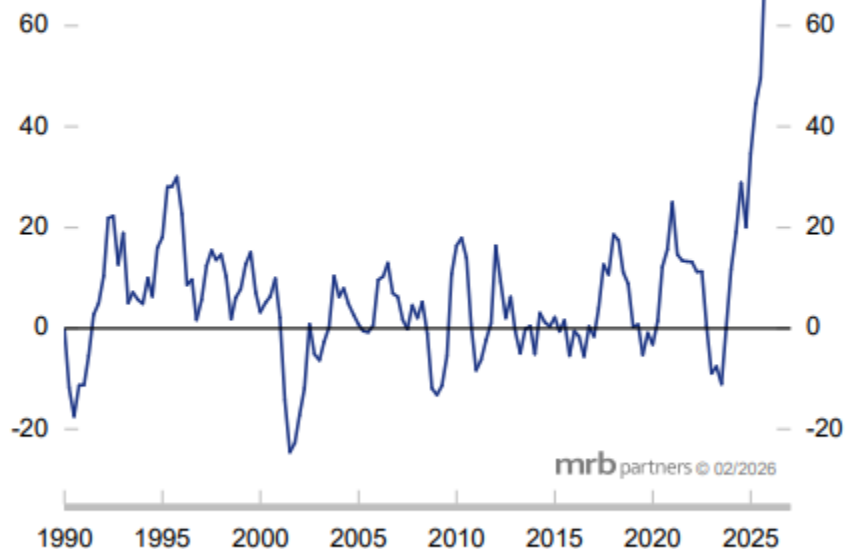

U.S. Datacenter Construction Spending* (US\$ bn)



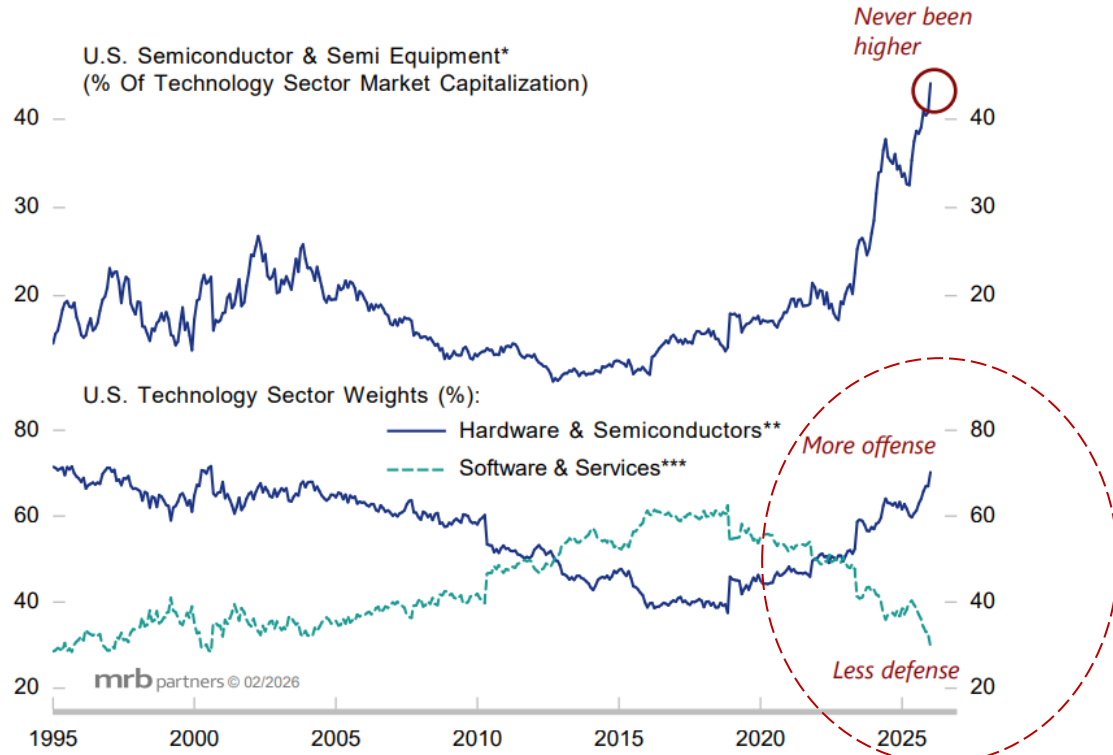
